FREE MEDICAL AND EYE CAMPS



Praise the Lord, we conducted free medical and eye camps from September 18-25 with the co-operation of IDES, among poor villagers of Kasur District. In those villages there are no medical facilities for poor patients. The team of Good Shepherd Christian Hospital treated them with the compassion, love, and mercy of Christ. Those who helped at the camps were Dr. Rehmat, Ethisham-eye specialist, Nasim Parvaiz, Principal of the Nursing School at United Christian Hospital, Sarah Parvaiz, psychologist, Samson Saleem, Administrator at GSCH, and Naylah Saleem.

Of the 815 patients who came to the camps, some were suffering from stomach problems, scabies, joint pain, body aches, respiratory tract infection, urinary tract infection, high blood pressure, diabetes, and gastrointestinal problems. 352 eye patients were treated for ailments such as cataracts, bacterial conjunctivitis, dry eyes, or keratitis.

FORCED CONVERSION IN PAKISTAN

A minor Christian girl, Pashman, was kidnapped and forcefully converted to Islam. Her father Gulzar, appealed to the Honorable Judge Tariq Nadeem at Lahore High Court to hand over his daughter to him, but the judge rejected his application, saying that Pashman has accepted Islam; whereas "the law is against the forced conversion of religion" (The Daily Jang, Lahore, September 24, 2021). But, the forced conversion of minor girls from minorities shall continue, and no one can dare to stop it!
